**WHO:** **UPCOMING SIXTH, SEVENTH, EIGHTH AND NINTH GRADERS** Camp is limited to the first 40 players  
(each player should bring bat, helmet, glove and cleats; wear baseball pants; catchers bring gear)

**WHAT:** Camp will cover position play, hitting mechanics and drills, baserunning and games each day. The games will be set up as a controlled scrimmage, as we will have baserunning situations at the beginning of each inning. These will be used as opportunities to teach where to throw the ball and why. These are also ways to teach situational hitting. I want each player to leave camp a smarter baseball player.

**WHEN:** June 14-16, 2010 - 1:00-4:30 p.m. (check-in or registration Monday from 12:30-12:55 p.m.)

**WHERE:** Karns Sportspark (8050 Oak Ridge Highway)
